CITY OF CANTON PERMIT APPLICATION

GOLF CARTS, MINI TRUCKS, UTILITY TASK VEHICLES (UTVs)

- Permits are valid for a single calendar year and cost \$10.
- Proof of current liability insurance must be kept on file with the City of Canton.
- No one under the age of 16 may operate golf carts, mini trucks or UTVs on streets, alleys or rights of way, not even with an adult in the passenger seat. Ignoring this requirement of a legally adopted City of Canton Ordinance may invalidate owner's liability insurance in case of an accident.
- Permits will not be issued to anyone under the age of 16.
- Permits will not be issued to applications who have had their state-issued driver's license revoked as the result of criminal proceedings.
- Mini trucks require a driver's license; golf carts and UTVs do not require a driver's license.
- Golf carts must display a slow-moving vehicle emblem on the rear of the vehicle.
- All vehicles must have a rearview mirror.
- Hours of operation are sunrise to sunset unless equipped with manufacturer installed lights front and rear.
- Vehicles may not be operated during inclement weather or during conditions of low light unless properly lighted.
- Occupants shall not exceed the design occupant load. Modified golf carts shall not exceed five (5) passengers. All passengers must be provided with an appropriate seat and remain seated at all times when the vehicle is in motion.
- Vehicle use is not permitted while under the influence of intoxicating liquor or narcotics or habitforming drugs.
- Golf carts and mini trucks must visibly display a current city-issued permit on the rear of the vehicle; UTVs must visibly display DNR-issued registration along with a city-issued permit.

NOTE: All Terrain Vehicles (ATVs) are not allowed to be operated on any street, alley, right of way, park property or playground within the City of Canton.
