### BY THE NUMBERS: HEARING SET ON RATE PROPOSALS

November 10 is your opportunity to weigh in on proposed increases to City of Canton public utility rates. The city council is holding a public hearing from 6 to 7 p.m. at the Canton Town Hall, prior to the regular monthly meeting.

Canton's current water and sewer rates have been in place since October 2017. Those rates were set, in part, by using Minnesota consumption data to estimate annual customer usage. As updated information now shows, Canton's actual water usage does not align with the statewide averages. Therefore, expectant revenue - particularly in water sales - is well below what was projected back in 1. A monthly water service charge of 2017. From January 1, 2020 through September 30, 2020, Water Fund revenues totaled approximately \$41,000; meanwhile, fund expenses came in at around \$49,000. Do the math and that's a loss of \$8,000. Simply put, the City cannot continue to operate under the present rate schedule.

This past summer, the number crunching began at city hall. With the assistance from the Minnesota Rural Water Association, various rate proposals including operating expenses, short-lived asset reserves and long-lived asset reserves - were prepared for city council review and discussion. At their October meeting, councilmembers decided to provide three water rate proposals for consideration at the required public hearing on the topic.

residential water Currently, Canton customers pay a total monthly service of \$17.50 (\$12.50 base fee + \$5.00 system upgrade fee) and a usage charge of

\$3.00 per 1,000 gallons of water used (\$0.003 per gallon). So, let's say you use 2,000 gallons of water in a given month - vour current water charges total \$23.50. Keep this number in mind as you read the proposals.



#### THE THREE PROPOSALS

- \$25.00 (increase of \$7.50) and a usage charge of \$5.86 per thousand gallons (\$2.86 increase). This option creates a monthly water total of \$36.72 for a 2,000 gallon user (monthly increase of \$13.22 for water services).
- 2. A monthly water service charge of \$28.50 (increase of \$11.00) and a usage charge of \$4.84 per thousand gallons (\$1.84 increase). This option creates a monthly water total of \$38.18 for a 2,000 gallon user (monthly increase of \$14.68 for water services).
- 3. A monthly water service charge of \$32.00 (increase of \$14.50) and no increase to the water usage charge; it would remain at \$3.00 per thousand gallons. This option creates a monthly water total of \$38.00 for a 2,000 gallon user (monthly increase of \$14.50 for water services).





# Winter parking rules start Nov. 1

Snow or no snow, alternate side street parking begins Sunday, November 1. It is in effect from 2 a.m. to 8 a.m., November through March, regardless of the weather forecast. Under this parking system, no vehicle is permitted to be parked on the even numbered side of any street on even numbered days, and no vehicle can be parked on the odd numbered side of any street on odd numbered days. Remember, you are parking for the calendar day at 2 a.m. Please share this information with overnight guests. Initially, sheriff deputies will be issuing warnings to owners of vehicles parked illegally. Repeat offenders may eventually receive a \$25 citation per offense; only the city council can waive a citation. Please contact city hall if you have questions about alternate side parking.

#### THE VERBIAGE

#### City Ordinance 71.04

From November 1 through March 31 of each year, between 2:00 a.m. and 8:00 a.m. each day, no motor vehicles, trailers, wagons or any other obstacles to snow plowing vehicles shall be parked on the even numbered side of any City Street on even numbered days, and no motor vehicle shall be parked on the odd numbered side of any City Street on odd numbered days.

While the Water Fund requires a significant financial boost, the Sewer Fund is in much better shape. As a result, the council has proposed no increase to the current monthly sewer service charge of \$33.00 for residential customers. A minimal monthly usage increase of \$0.00004 per thousand gallons used is on the table. Currently, the cost is \$2.40 per thousand gallons (\$0.0024 per gallon); the proposed increase brings that to \$2.44 per thousand gallons (\$0.00244 per gallon). Using 2,000 gallons as the monthly example, we're talking sewer charges totaling **\$37.80** under current pricing, with the proposed increase adding just \$0.08 – bringing the monthly total to **\$37.88** for a residential sewer customer.

All of these numbers will be further explained during the public hearing on Tuesday, November 10, from 6 to 7 p.m. Jeff Dale, with the Minnesota Rural Water Association, will also be in attendance. The city council is scheduled to vote on a rate increase plan that evening. The new rates will take effect on January 1, 2021.
