- Permits are valid for a period of one year, from May 1 through April 30, and must be renewed annually at a cost of \$10.
  - Proof of current liability insurance must be kept on file with the City of Canton.
  - No one under the age of 16 may operate golf carts, mini trucks, UTVs and ATVs on streets, alleys or rights of way, not even with an adult in the passenger seat. Ignoring this requirement of a legally adopted City of Canton Ordinance may invalidate owner's liability insurance in case of an accident.
  - Permits will not be issued to anyone under the age of 16.
  - Permits will not be issued to applications who have had their state-issued driver's license revoked as the result of criminal proceedings.
  - Golf carts must display a slow-moving vehicle emblem on the rear of the vehicle.
  - All vehicles must have a rearview mirror.
  - Hours of operation are sunrise to sunset unless equipped with manufacturer installed lights front and rear.
  - Vehicles may not be operated during inclement weather or during conditions of low light unless properly lighted.
  - Occupants shall not exceed the design occupant load. Modified golf carts shall not exceed five (5) passengers. All passengers must be provided with an appropriate seat and remain seated at all times when the vehicle is in motion.
  - Vehicle use is not permitted while under the influence of intoxicating liquor or narcotics or habit-forming drugs.
  - All vehicles must visibly display a current city-issued permit on the rear of the vehicle.
